

# BUILDING UP THE COMMON GOOD

Opportunities to Respect and Protect All Human Life

On June 24, 2022, the U.S. Supreme Court overturned the 1973 Roe vs. Wade case, thus removing the constitutional right to abortion. The Supreme Court decision does not ban abortions, but it provides opportunities for dialogue and discernment about how to assist women, protect the unborn, and begin anew. The Catholic community welcomes this opportunity. We share with other people of good will the conviction that all human life must be respected and protected from conception to natural death. Life is a gift of God entrusted to our care. To be truly pro-life means that it is never enough to oppose abortion; the Church is also called to address root causes that lead to abortions and to find ways to support both women and children so that all may flourish. As a community of faith, we must be instruments of accompaniment and healing.

We offer the following resources to help parish leaders and Catholic school principals form their faith communities and equip catechists, teachers and parents to engage in conversations with children, youth and one another about respecting and protecting all human life, through the lens of faith and grounded in compassion.

# Statement of Cardinal Blase J. Cupich, archbishop of Chicago, on the Supreme Court's Decision in Dobbs v. Jackson Women's Health Organization

Today, the U.S. Supreme Court issued its ruling in Dobbs v. Jackson Women's Health Organization, which overturns the court's tragic 1973 decision that removed legal protection for unborn children. We welcome this important ruling and the opportunity it creates for a national conversation on protecting human life in the womb and promoting human dignity at all stages of life. This moment should serve as a turning point in our dialogue about the place an unborn child holds in our nation, about our responsibility to listen to women and support them through pregnancies and after the birth of their children, and about the need to refocus our national priorities to support families, particularly those in need.

The Catholic Church brings to such a conversation the conviction that every human life is sacred, that every person is made in the image and likeness of God and therefore deserving of reverence and protection. That belief is the reason the Catholic Church is the country's largest provider of social services, many aimed at eliminating the systemic poverty and health care insecurity that trap families in a cycle of hopelessness and limit authentic choice.

We also come to this dialogue as Americans, knowing that the principle that all human beings are endowed by the Creator with certain inalienable rights is enshrined in the Declaration of Independence, and that first among these is the right to life.

Make no mistake, because this ruling regrettably will have little impact on abortion in Illinois, as there are virtually no restrictions here, we will continue to advocate strongly for legal protections for unborn children. And we will redouble our efforts to work with all to build a culture that values the inalienable rights to life, liberty and the pursuit of happiness for all.

This ruling is not the end of a journey, but rather a fresh start. It underscores the need to understand those who disagree with us, and to inculcate an ethic of dialogue and cooperation. Let us begin by examining our national conscience, taking stock of those dark places in our society and in our hearts that turn to violence and deny the humanity of our brothers and sisters, and get to work building up the common good by choosing life.

# The 1973 Decision and the 2022 Ruling

"The recent Supreme Court decision Dobbs v. Jackson overturned the Supreme Court's 1973 decision Roe v. Wade. That earlier decision removed legal protection for unborn children in our nation...This Supreme Court decision does not ban abortions, but it does redirect our nation, particularly the states, to a conversation and decision-making process about how best to protect the unborn. Therefore, the decision Dobbs v. Jackson is not the conclusion of the issue, but an opportunity to begin anew." (**Pulpit Points #1 and #3**)

# The Sanctity of All Human Life

"This ruling is a challenge and an opportunity for Catholic citizens to call for and contribute to a national conversation on protecting and promoting human dignity at all stages of life. This moment should serve as a turning point in our dialogue about the place an unborn child holds in our nation, about our responsibility to assist women through unplanned and difficult pregnancies and after the birth of their children, and about the need to refocus our national priorities to support families, particularly those in need.
