A Place Where People Share Their Challenges and Hopes Through Faith



WHAT IS A PEACE CIRCLE?

It is a pastoral exercise that allows people to share their challenges, fears, and hopes in a safe and trusting environment. It leads a person to analyze through their faith what is happening in an environment of compassion.

COMPONENTS OF A PEACE CIRCLE

Pastoral: Share experiences as a group exercise

Information: Legal presentations by immigration attorneys or by the Mexican Consulate

Social: Community resources to respond to the needs of immigrant people

PROCESS OF A PEACE CIRCLE

- 1. People will join small groups to share the following questions:
 - What feelings are you experiencing?
 What is God's message with everything that is happening?
 - What actions can we organize to respond to the needs of the community?
- 2. Secondly, there is a presentation by a lawyer or qualified staff on issues relevant to the community: Know Your Rights, immigration, deportation, Guardianship, mental health, etc.
- 3. Finally, the Consulate of Mexico or another consulate from Latin America offers information regarding consular services for the community.

BENEFITS OF A PEACE CIRCLE

Accompaniment: Participants express their fears and worries within the faith context while forming support networks to face their challenges as a family in Christ.

Information: The presentations provide relevant and trustworthy information on topics that affect the lives of immigrant families.

Develop Leadership: Peace Circles exhort people to actively participate in their parish communities and respond to their baptismal call to serve and work for justice.
